







STUDENT DEMOGRAPHICS






DISTRICTS OF RESIDENCE




STATE REPORT CARD





CHATA earned a Performance Index score of 65.4 and continued to advance student progress. Over the course of the year, students on or above grade level in math increased by 20% and the amount of students on or above grade level in ELA increased by 25%.
